VII. Board Liaison Report

- Township Trustee Alex Williams reported that extensive discussion of proposed burning ordinance #185 took place at the last board meeting. This ordinance passed first reading at the meeting. Two appointments were made to the Planning Commission, one a reappointment and one new member. The township board approved repairs to the Utility Department pump station at LeForge and Clark roads. The health insurance contract with Priority Health HMO was extended for one month. The new contract will call for employees to pay \$25.00 per month (single) and \$50.00 per month (family) toward the premium expense. The annual "drive around" with the Washtenaw County Road Commission is scheduled for Wednesday 2/27/13.
