

## PARKS & RECREATION

SUPERIOR TOWNSHIP PARK COMMISSION Regular Meeting – April 27, 2009 Old Township Hall 7:00 p.m. ADOPTED MINUTES

## 1) CALL TO ORDER:

The regular meeting of the Superior Township Parks and Recreation Commission was called to order at 7:00 p.m. on April 27, 2009 at Old Township Hall.

Growing Hope and Cherry Hill Nature Preserve burn was added to agenda. It was moved by Wilbanks supported by Morris that the agenda be approved.

#### A. Chairperson:

Berry e-mailed the Ann Arbor News to alert them to cover the Green Fair. She also reported that the Cherry Hill Nature Preserve burn was successful and a lot of wild flowers are beginning to grow after the burn. She stated that a bald eagle was photographed in Cherry Hill Nature Preserve. She thanked Dave Buterbaugh and his crew for removing trash and debris from the area next to Westridge.

C. Growing Hope:

The Board discussed Project Growing Hope which encourages community members to grow more of their own food. The program has raised beds which could be installed in the local parks for resident growing needs. Buterbaugh stated that security and location might be an issue in the parks and Morris stated that access to water might be difficult in some of the more rural parks. Commissioners concluded Schock Park is the best location.

D. CHNP Burn:

Cherry Hill Nature Preserve controlled burn cost \$3,375. Kern-Boprie moved that we pay David Bourneman for the Cherry Hill Nature Preserve controlled burn. Morris supported and the motion passed unanimously by roll call vote.

E. Administrator Review:

Wilbanks moved, supported by Morris, that Berry complete Lockie's employment review. The motion passed.

Wilbanks moved, supported by Morris, to pay the bills totaling \$2,282.52. The motion carried unanimously.
