## COMMITTEE TO PROMOTE SUPERIOR TOWNSHIP – "One Superior Place" Meeting December 5, 2018

**Remarks and Announcements –** Brenda Baker and Carla Bisaro attended; regrets were received from Nancy Caviston. Brenda also informed us that she had received a message in November from Jane Frye, regretting that health concerns would likely keep her from active participation in the group. Because of meeting schedule conflicts in October, January and February, Brenda reported that her intent was to send our yearly report to the Board of Trustees in December. Because an oversight kept us from meeting at Township Hall for this December meeting, Brenda and Carla met informally to exchange information.

**Library Display/Bookmarks/Superior Places Binders –** Carla reported that she had placed a new poster at the library, after reworking the Dixboro poster to feature both Dixboro and Frains Lake. New Superior Places pages are currently in the works, and as they are finalized, they will be added to the binders and bookmarks will be made.

Internet/Website – There was no discussion of this agenda topic.

**Superior Places** – Carla presented new profiles on Superior Farm and Garden (previously named Superior Feed in our agendas), the Dixboro-Matthaei Trail and the Michigan Folk School. Copies were distributed for comments and approval. It was noted that, as work progresses on what will be named the Staebler Farm County Park, our Superior Places profile might require revision. Brenda also suggested that investigation into the history of First Street, near the Huron River, might yield an interesting Superior Places presentation. There continues to be no progress reported on the topics of Huron Valley Nighthawks Motorcycle Club, MacArthur Boulevard, Equine Life, Birds, or Business in the Township. The Ford Farm continues to be an inactive topic.

**Events, Outreach and Community Pride** – Carla reported that there continues to be a supply of the hometown address "Where Do You Live?" flyer in the Township Hall vestibule. It was suggested that we might consider additional/larger material for display at the Dixboro Farmers' Market when it opens in the spring. On the topic of Information Placement, Brenda noted that the Township marquee is currently getting good use. Other sub-topics were not considered, except in relation to our new refrigerator magnets. The new magnets, listing contact information for various aspects of Township services, are complete and well done. A number of them have been augmented with a sticker on the reverse showing information about our committee. Many of these have been distributed at the tree lighting activity, and are planned for inclusion in the New Resident Welcome Packet. Finally, Carla reported on the tree lighting activity with Township Parks & Rec. She had made contact with Chris Troiano, the ice carver, on behalf of Parks & Rec, and she and Nancy arrived early at the activity to assist the Parks personnel. There was no discussion on a springtime family bike ride event.

**Schedule Next Meeting –** Returning to the regular third Wednesday meeting schedule, the next meeting is scheduled for 7:00 p.m., Wednesday, January 16, 2019, at Superior Township Hall.
