1. CALL TO ORDER

The special meeting of the Charter Township of Superior Board of Trustees was called to order by the Supervisor Ken Schwartz at 7:00 p.m. on December 14, 2021, at the Superior Township Hall, 3040 North Prospect, Superior Township, Michigan.

2. PLEDGE OF ALLEGIANCE

Supervisor Schwartz led the assembly in the pledge of allegiance to the flag.

3. ROLL CALL

The members present were Supervisor Ken Schwartz, Clerk Lynette Findley, Treasurer Brenda McKinney, Trustee Nancy Caviston, Trustee Lisa Lewis, Trustee Bernice Lindke, and Trustee Rhonda McGill.

Absent: None

4. ADOPTION OF AGENDA

It was moved by Treasurer McKinney supported by Trustee Lewis, to adopt the agenda as presented.

The motion carried by unanimous vote.

Supervisor Schwartz read a memo giving the audience and Board some background regarding the Rock property.

5. PUBLIC COMMENTS (Limited to two minutes per person)

- Greg Vessels, 333 East Clark Road, conveyed his gratitude to the Board of Trustees for standing up to these developers.
- Matthew Schuster, resident on Geddes Road, owns the cultural land and is a strong advocate for green space. He asked the Board what the plan for the property is and how it fits into the Township's Master Plan.
- Carla Bisaro, resident on Paddock Way, voiced her support for the purchase of the property.
- Louis Ferris, resident on Vorhies Road, stated his support for the purchase of the land based on the need for more open space and less development. He stated the Township purchasing this property will help stop the developments coming in.
- John Miller, resident on Ann Arbor Road, stated once a piece of land is developed it is gone forever and voiced his support for the purchase of this property.

- Tanya Hilgendorf, CEO of Huron Humane Society, voiced her support for the purchase of the property to continue protecting the wildlife corridors. She expressed the need for more space for wildlife and that the planet is made up of only 4% wildlife.
- William Secrest, resident on Cherry Hill Road, stated this is not a local situation but a global situation. He expressed his support for the Township purchasing the property.
- Michelle McIntyre, resident on Crab Apple Drive, stated her support for the purchase of the land due to the physical and mental health benefits open spaces has provided her family.
- Steven Przybylski, Meadow Lane, speaking on behalf of his wife, Michelle Deatrick, and himself, explained the citizens voted on a millage for funds to use for legal expenses to fight the Rock property from being developed and would like the Township to use those funds, if possible, to purchase the property.
- Michael David Bendor, resident on Stommel Road, explained the importance of protecting this land upon purchase of it.
- Ellen Kurath, resident on Hickman Road, explained her concerns regarding the soils on the Rock property.
- Jack Smiley, resident on Cherry Hill Road, voiced his full support for the purchase of the
 property. Rock is agreeing to sell the property less than it appraised two years ago and
 less than what they paid for it eighteen years ago. He believes if the Township does not
 purchase this property, that it will be developed and will cost the Township a lot more
 down the road.
- Nahid Yahyai, 3500 Blue Heron Court, voiced her support in purchasing the land and praised the Board for their hard work.

6. **COMMUNICATIONS**

A. Emails from residents

It was moved by Treasurer McKinney supported by Trustee Lindke, to receive the letters of commendation.

The motion carried by unanimous vote.

7. NEW BUSINESS

Supervisor Schwartz explained he would like there to be a conservation easement on the entire 301 acres for park usage and develop a small summer camp for children. A township cannot go to the bank and get a mortgage. The land can be purchased through a bond funded by a millage or general fund. Supervisor Schwartz has contacted a bond company. Act 99 allows a township to buy land by a land contract. Supervisor Schwartz read a letter from the Township's Controller, Keith Lockie. The general and legal defense funds have adequate funds available for the terms of the purchase of the Rock property. The estimated cost is about \$125,000.00 per year for the payment. The bond council has reviewed the contract. Once the Township has the deed, then they can put the conservation easement on the entire property. The Township has no plan to

develop this property. Supervisor Schwartz explained the purchase agreement is being approved tonight and the land contract will be taken to the Board later. The terms of the land contract are \$250,000.00 down and has not been determined where this money is going to come from. The funds can be taken from the general fund. The legal defense funds can be used for the development of the property later.

Supervisor Schwartz mentioned some of the forty-two letters of support the Township received regarding the purchase of the Rock property.

United States Representative Debbie Dingell communicated with Treasurer McKinney her support for the purchase of the property.

A. Letter to Supervisor Schwartz regarding Rock Property dated August 17, 2021

Supervisor Schwartz read the letter from Butzel Long Attorneys and Counselors.

It was moved by Clerk Findley supported by Treasurer McKinney, to receive letter of commendation.

The motion carried by unanimous vote.

B. Proposed Sales Agreement and Proposed Land Contract for Rock Property

It was moved by Treasurer McKinney supported by Trustee Lewis, to approve the sales agreement with Rock Superior LLC and authorizes the Township's attorney to take all the necessary steps and subject to administrative changes and adding another WHEREAS clause stating the future usage of the property.

Trustee Lindke stated she supports the purchase, but the resolution needs a lot of work. She reviewed some of the edits she suggests making on the resolution. Trustee Lindke asked if there could be a WHEREAS clause on the resolution stating what the Township plans to do with the property. Supervisor Schwartz stated the resolution can be adopted subject to administrative changes. Trustee McGill asked for clarification on some of the language in the resolution. She also asked for clarification on what funds were being used to purchase the Rock property.

Clerk Findley stated she has always been in support of purchasing the property but is concerned about the transparency and decisions about purchasing this property. She stated there is a population specifically Sycamore Meadows and Danbury Green who come to these meetings and beg the Township for things, and they walk away with nothing. She stated those people are our future, and we must help develop them.

- Jan Piert also thanked Clerk Findley for her comments and really would like the Board to do something about that. She stated we are one community.

1. CALL TO ORDER

The work session of the Charter Township of Superior Board was called to order by the Supervisor Ken Schwartz at 4:36 p.m. on December 20, 2021, at the Superior Township Hall, 3040 North Prospect, Superior Township, Michigan.

2. ROLL CALL

The members present were Supervisor Ken Schwartz, Clerk Lynette Findley, Treasurer Brenda McKinney, Trustee Lisa Lewis, Trustee Bernice Lindke, and Trustee Rhonda McGill.

Absent: Trustee Nancy Caviston

3. PUBLIC COMMENT/ DISCUSSION AMERICAN RESCUE PLAN ACT (ARPA) FUNDS

- Jan Piert, resident on Anns Way, asked the Board if this work session could be an open discussion like the previous work session was.
- Roderick Casey, Ypsilanti Township resident, is observing to get insight before Ypsilanti Township goes through this process.
- Gail Summerhill, Ypsilanti Township resident, here to observe and explained she would like the ARPA funds to be spent on the people it was intended to be spent on.
- Lavada Jefferson Weathers, Ypsilanti Township resident, addressed the Board about turning Cheney Elementary School into a community center for Superior Township and naming it after Johnny B. Cheney who was the first black teacher in Willow Run Community Schools.
- Trustee Lindke asked for clarification on what Ms. Weathers was asking. She asked that Cheney Elementary be made into a community center.
- Supervisor Schwartz stated in 2015, the Township Board made an offer to the schools to buy Cheney Elementary, and they wanted to sell it for the market price. Ms. Weathers stated she can assure Supervisor Schwartz that Ypsilanti Community Schools is ready to sell the property to the Township. Supervisor Schwartz explained the process of building a new community center and that remodeling Cheney Elementary could move fast.
- Treasurer McKinney stated there are 12-acres at the corner of Harris Rd. and Geddes Rd. to put a new community center.
- Ms. Piert asked how soon this could all be done. She suggested allocated the ARPA funds to this community center.
- Treasurer McKinney voiced her support of not leaving out Arbor Woods and Westridge. Ms. Piert stated she is not forgetting those communities, but people do not know where those mobile home parks are, but they do know where Sycamore Meadows and Danbury Park Manor are.
- Clerk Findley stated the next move should be sending a letter to the Ypsilanti Community Schools Superintendent. Supervisor Schwartz stated he will send the letter by email. Trustee Lindke would like the letter to be sent out by the whole board. Clerk Findley

stated the community center is needed in this community, and this needs to be acted upon quickly.

- Supervisor Schwartz commented on the \$50 million bond. Cheney Elementary is securing the bond.
- Ms. Piert explained that Kathy Wyatt is working on a plan to bring in the County as a partner for the community center.
- Ms. Summerhill addressed her concerns around why the community doesn't show up to meetings and why they don't understand what the Board of Trustees does.
- Supervisor Schwartz explained the Township's efforts for outreach to the Sycamore Meadows and Danbury Park Manor.
- Clerk Findley stated the results of the Master Plan Committee survey were skewed. She explained the results showed the community was not interested in diversity as it relates to housing. She stated she spoke up for those who were not able to be at the meeting.
- Ms. Piert explained to be able to get information through surveys, you must sit with them and coach them through the survey. She praised Kelly Goolsby for her efforts with the County's survey regarding ARPA funds.
- Trustee McGill stated she ran for office because she wants to listen to the people and what they want.
- Trustee Lindke wants to propose a resolution tonight to spend 100% of the ARPA funds on the qualified census tract. Clerk Findley stated she would support this. Treasurer McKinney asked for clarification on this resolution.
- Ms. Piert stated she strongly opposes the resolution going to the Board tonight regarding the Bromley Park bike path.
- Ms. Summerhill stated ARPA funding should be spent on the people who are hurting the most. She explained the Ypsi Can I Share website has done a great job explaining that the Board of Trustees work for the people of the community.
- Supervisor Schwartz stated the Board agrees to send a letter to Ypsilanti Community Schools inquiring about the Cheney Elementary School. Supervisor Schwartz stated he will have to oppose the resolution regarding spending 100% of the ARPA funds on the qualified census tract. He would like to replace the air filtration system in the Township Hall.
- Ms. Summerhill explained the funds were intended to be spent on the people in need in our community.
- Trustee McGill stated she would like to use the money for the people impacted by COVID-19. She asked Clerk Findley how many people come into the Township Hall to vote and how often they do. She expressed her interest in using the funds in the southside of the Township. She stated we must do better.
- Trische Duckworth addressed the Board and stated that the community needs to be heard and the ARPA funds need to be spent on the MacArthur Blvd area. She stated the ARPA funds were intended to be spent on the disenfranchised communities. She asked for Supervisor Schwartz look her in her eyes when she talks.

- Supervisor Schwartz asked what Washtenaw County is doing with the ARPA funds. Ms.
 Summerhill addressed her concerns with the County spending their funds and how the COVID-19 vaccine was administrated.
- Ms. Piert stated Washtenaw County was given \$71 million, and they added \$30 million of their own money to the pot to be able to spend money differently. The first resolution was for broadband infrastructure for the western side of the County, weatherization, and daycare program in response to Ann Arbor Public Schools closing their daycare. They hired Peter Lindeman, Communications and Operations Manager for the County, who has helped get communications out to the public and establish listening sessions for the ARPA funds. The County has then proposed allocating the money specifically to the 48197 and 48198 areas. Ms. Piert stated County Administrator Dill would like to see a joint task force in using the County funds and Township funds to build a community center.
- Clerk Findley stated the County allocations could be combined with the Township's.
- There was discussion regarding what the old Willow Run High School is being used for currently. Supervisor Schwartz stated Sheriff Clayton has always proposed the idea of no big recreation center and do small community centers in the different communities.
- Ms. Summerhill asked if the letter for Ypsilanti Community Schools could be sent out tomorrow (12/21/2021) by noon.
- Ms. Piert asked the Board if we could fix the flooding at Fireman's Park. She would like to focus on the Township being a community.
- Ms. Duckworth asked if the Township could get involved with fixing up Sycamore Meadows. Supervisor Schwartz explained the process on how to keep the owners of Sycamore Meadows accountable. He explained there is an ordinance in place.

6. <u>CITIZEN PARTICIPATION</u>

A. CITIZEN COMMENTS

- John Nydam, resident on Warren Road, explained his concerns with the
 infestation of gypsy moths. He explained they have taken out the white oaks and
 red oaks in the Township. Oakland County has put together a 2022 spray corp.
 program. He is asking for the Township's help. He passed out pictures of the trees
 that have been affected.
- Gerald Constance, resident on Warren Road, stated the gypsy moths are throughout the entirety of Warren Road and Cherry Hill Road. He also expressed his concerns with the gypsy moths killing the oak trees. He passed out pictures of potholes on Warren Road. The Washtenaw County Road Commission is stating they are not responsible for the roads. He asked about keeping the ditches clear on Warren Road. Supervisor Schwartz encouraged both residents to come to the Washtenaw County Road Commission meeting to express their concerns for Warren Road.
- Jan Piert, resident on Anns Way, voiced her support for the new resolution of allocating the American Rescue Plan Act funds to the community who needs it the most. She also asked the Board to pass a resolution to commit to a community center.
- Gail Summerhill, Ypsilanti Township resident, voiced her concern about the sign on the door requiring a mask and seeing people walk around without a mask.
- Merve Hickok, 5626 Geddes Rd., voiced her support for the resolution for allocating the funds to the disenfranchised community in the Township.
- Jan Piert, resident on Anns Way, stated she agrees with Resolution 2021-74 but not to use the American Rescue Plan Act funds.
- Trische Duckworth thanked the Board for the work session. She asked the Board if there could be a community person to work with for the Township or if there could be a community engagement office established in the Township. She suggested asking Kelly Goolsby to assist. Clerk Findley stated Kelly Goolsby has been assisting with a family who had a death in the family. Clerk Findley asked if Supervisor Schwartz knew about the death. Supervisor Schwartz stated he found out from the Fire Chief about it. She asked if the Board could receive this information also in the future.
- Irma Golden, resident in Oakbrook, voiced her interest for being a member of the Board of Review. She asked the Board what the process is when choosing Board

of Review members. Trustee Lindke stated she received information regarding Irma Golden and answered her as a Board member. She thanked Ms. Golden for attending the meeting this evening.

Supervisor Schwartz explained the situation. He stated he is ready to vote yes to requiring a private road permit.

It was moved by Trustee Caviston, supported by to Treasurer McKinney to vote regarding the issue of health, safety, and welfare of the Huron River near 5766 and 5728 Geddes Road.

Trustee Lewis expressed her concerns with Mr. Schuster dealing with this situation for quite some time and hopes it can be resolved soon.

Clerk Findley asked what Rick Mayernik's, Building and Zoning Official, position on this subject is. She also stated she does not feel comfortable voting on this tonight. She would like to table this issue again.

Supervisor Schwartz stated Mr. Mayernik told him he had no objection for the Board to move this way.

Clerk Findley stated she was against the motion because there are two sides, and the Mouliere's have chosen not to air their side in public. We are following our ordinances and zoning policies.

Matt Schuster stated this is just recognizing the framework that was placed by the Township fifteen years ago be upheld and to protect the wetlands.

Trustee Lindke asked how this would affect the Mouliere's if the Board voted yes on the issue of health, safety, and welfare of the Huron River near 5766 and 5728 Geddes Road. Supervisor Schwartz stated this would require a private road permit for the Moulier's. If the Township votes no, then the Township does not have any control over the Mouliere's driveway.

She would like to have a working session before setting the official's salaries. She believes there is a need to discuss about the salaries before making decisions on them.

Clerk Findley asked if this is taking some of Jennifer Neff's responsibilities away.

Trustee McGill stated there should be serious conversation about the structures of salaries. She stated she understands the roles of Deputy Clerk and Deputy Treasurer are two separate roles. It needs to be explained to everybody that they are not regular employees.



Re: December 1-31, 2021 Police Services Monthly Report

During the month of December there were 1,017 calls for service. Deputies conducted 464 traffic stops during this time with 63 citations issued and 5 drunk/drugged driving arrests.

Noteworthy events in Superior Township during last month include:

•	21-85042	(12/2/2021) Deputy Gombos and Deputy Howard attempted to stop a vehicle at MacArthur Blvd near Clark Road. The driver failed to stop and a short pursuit ensued. Once the vehicle stopped, deputies began to approach on foot but the driver fled south on Rue Willette at a high rate of speed. The deputies did not continue to chase but did locate the vehicle unoccupied a short distance away and recovered suspected narcotics and paraphernalia inside the vehicle.
•	21-85703	(12/4/2021) Deputy Vanderroest was dispatched to the block 1900 Ridgeview for a stolen vehicle report. The victim believed a friend stole her keys and the vehicle. It was later recovered, unoccupied in Ypsilanti Township.
•	21-86108	(12/5/2021) Deputies responded to a shots fired call on Hamlet Drive. They were unable to locate anything suspicious or the source of shots.

NOW, THEREFORE, BE IT RESOLVED, that the Charter Township of Superior Board of Trustees does hereby approve the animal control contract with the County of Washtenaw as presented in an amount not to exceed \$10,000.00 and authorizes the Supervisor to execute the same on behalf of the Township.

CONTRACT Superior Charter Township

AGREEMENT is made this 11th day of January, 2021, by Superior Charter Township located at 3040 N. Prospect Road, Ypsilanti, MI and the COUNTY OF WASHTENAW, a municipal corporation, with offices located in the County Administration Building, 220 North Main Street, Ann Arbor, Michigan 48107("County").

In consideration of the promises below, the parties mutually agree as follows:

ARTICLE I - SCOPE OF SERVICES

Whereas, under Michigan law, a county is responsible for undertaking certain animal control duties, including the holding of stray dogs under the Dog Law of 1919 (MCLA 287.261 et seq), impounded animals held for a variety of reasons, including dog bites and animal cruelty or animals ordered by a court to be held as part of a legal proceeding; and

Whereas, for many years, Washtenaw County has contracted with the Humane Society of Huron Valley (HSHV) to provide these animal control services; and

Whereas, for the past six years, those local government entities within Washtenaw County that maintain their animal control ordinances and use HSHV to their ordinance responsibilities have been paying a portion of those HSHV costs; and

Whereas, HSHV has maintained that it would like to recoup those costs and expenses incurred in providing animal control services to the county and local government entities that use its services; and

Whereas, under the proposed contract, the county would act as the lead governmental entity responsible to make the monthly contractual payments to HSHV and ensuring that the local governmental entities pay for their use of HSHV services

ARTICLE II - COMPENSATION

Upon completion of the above services and submission of invoices the Superior Charter Township will pay the COUNTY an amount not to exceed ten thousand dollars (\$10,000.00)

ARTICLE III - TERM

This contract begins on the date of this agreement and ends on August 31, 2021 with an option to extend for one (1) additional one (1) year period.

ARTICLE IV - EQUAL EMPLOYMENT OPPORTUNITY

The County will not discriminate against any employee or applicant for employment because of race, creed, color, sex, sexual orientation, national origin, physical handicap, age, height, weight, marital status, veteran status, religion and political belief (except as it relates to a bona fide occupational qualification reasonably necessary to the normal operation of the business).

The County will take affirmative action to eliminate discrimination based on sex, race, or a handicap in the hiring of applicant and the treatment of employees. Affirmative action will include, but not be limited to: Employment; upgrading, demotion or transfer; recruitment advertisement; layoff or termination; rates of pay or other forms of compensation; selection for training, including apprenticeship.

The County agrees to post notices containing this policy against discrimination in conspicuous places available to applicants for employment and employees. All solicitations or advertisements for employees, placed by or on the behalf of the County, will state that all qualified applicants will receive

consideration for employment without regard to race, creed, color, sex, sexual orientation, national origin, physical handicap, age, height, weight, marital status, veteran status, religion and political belief.

ARTICLE V - EQUAL ACCESS

The County shall provide the services set forth in Article I without discrimination on the basis of race, color, religion, national origin, sex, sexual orientation, marital status, physical handicap, or age.

ARTICLE VI - ASSIGNS AND SUCCESSORS

This contract is binding on Superior Charter Township and the County, their successors and assigns. Neither the County nor the Superior Charter Township will assign or transfer its interest in this contract without the written consent of the other.

ARTICLE VII - TERMINATION OF CONTRACT

Section 1 - Termination without cause. Either party may terminate the contract by giving thirty (30) days written notice to the other party.

ARTICLE VIII - CHANGES IN SCOPE OR SCHEDULE OF SERVICES

Changes mutually agreed upon by Superior Charter Township and the County, will be incorporated into this contract by written amendments signed by both parties.

ARTICLE IX - CHOICE OF LAW AND FORUM

This contract is to be interpreted by the laws of Michigan. The parties agree that the proper forum for litigation arising out of this contract is in Washtenaw County, Michigan.

ARTICLE X - EXTENT OF CONTRACT

This contract represents the entire agreement between the parties and supersedes all prior representations, negotiations or agreements whether written or oral.

RESOLUTION APPROVING 2022 POVERTY EXEMPTION GUIDELINES FOR THE BOARD OF REVIEW

RESOLUTION NUMBER: 2022-3

DATE: JANUARY 18, 2022

WHEREAS the adoption of guidelines for poverty exemptions is required of the Township Board; and

WHEREAS, the principal residence of persons, who the Board of Review determines by reason of poverty to be unable to contribute to the public charge, is eligible for exemption in whole or in part from taxation under Public Act 390 of 1994 (MCL 211.7u); and

WHEREAS, pursuant to PA 390 of 1994, the Charter Township of Superior, Washtenaw County adopts the following guidelines for the Board of Review to implement. The guidelines shall include but not be limited to the specific income and asset levels of the claimant and all persons residing in the household, including any property tax credit returns, filed in the current or immediately preceding year;

To be eligible, a person shall do all the following on an annual basis:

- 1) Be an owner of and occupy as a principal residence the property for which an exemption is requested.
- 2) File a claim with the assessor or Board of Review, accompanied by federal and state income tax returns for <u>all persons</u> residing in the principal residence, including any property tax credit returns filed in the immediately preceding year or in the current year.
- 3) File a claim reporting that the combined assets of <u>all persons</u> do not exceed the current guidelines. Assets include but are not limited to, real estate other than the principal residence, personal property, motor vehicles, recreational vehicles and equipment, certificates of deposit, savings accounts, checking accounts, stocks, bonds, life insurance, retirement funds, etc.
- 4) Produce a valid driver's license or other form of identification if requested.
- 5) Produce, if requested, a deed, land contract, or other evidence of ownership of the property for which an exemption is requested.
- 6) Meet the federal poverty income guidelines as defined and determined annually by the United States Department of Health and Human Services or alternative guidelines adopted by the governing body providing the alternative guidelines do not provide eligibility requirements less than the federal guidelines.
- 7) The application, Michigan Department of Treasury form 5737 (01-21) shall be filed after January 1, but one day prior to the last day of the December Board of Review. The filing of this claim constitutes an appearance before the Board of

Review for the purpose of preserving the right of appeal to the Michigan Tax Tribunal.

The following are the federal poverty income guidelines which are updated annually by the United States Department of Health and Human Services. The annual allowable income includes income for all persons residing in the principal residence. The Superior Township annual allowable income is also included for all persons residing in the principal residence.

Asset Test

The applicant is required to provide a list of assets for all persons residing in the residence. Expenses and extenuating financial circumstances that are temporarily beyond the control of the applicant will be considered. Based upon the assets and income listed on a poverty exemption application, the Board of Review may grant the applicant 100%, 50% or 25% reduction in taxable value. An applicant could meet the income guidelines but not the asset guidelines.

The total assets for all persons residing in the residence excluding the homestead shall not exceed \$20,000.

Assets include but are not limited to:

- A second home, land, vehicles
- Recreational vehicles such as campers, motorhomes, boats, and ATV's
- Buildings other than the residence
- Equipment, other personal property of value
- All Bank accounts, stocks
- Money received from the sale of property, such as, stocks, bonds, or a house or car (unless a person is in the specific business of selling such property)

- Withdrawals of bank deposits and borrowed money
- Gifts, loans, lump-sum inheritances, and one-time insurance payments
- Food or housing received in lieu of wages
- Federal non-cash benefits programs such as Medicare, Medicaid, food stamps and school lunches

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Review shall follow the above stated policy and federal guidelines in granting or denying an exemption. Based upon the assets and income listed on a poverty exemption application, the Board of Review may grant the applicant 100%, 50% or 25% reduction in taxable value.

WHEREAS, on December 14, 2021, the Board of Trustees authorized the sales agreement to purchase 301 acres known as the Rock Superior LLC property in sections 20, 29 and 30 pursuant to Resolution 2021-79; and,

WHEREAS, the resolution did not specify the fund to pay the down payment and term until after there was clarification whether the legal defense fund could be used; and,

WHEREAS, it was determined that the legal defense fund could be used for the purchase but that a conservation easement could not be perfected until the deed for all the parcels transferred, and that it is in the best interest of the legal defense fund to not fund any of the acquisition until such time as the township receives the deeds and protects the property for resident use and enjoyment.

NOW THEREFORE BE IT RESOLVED, that funding for the down payment and term of the Rock Superior LLC and the Superior Township land contract shall be from general fund reserves.

WITNESSETH:

1. Seller Agrees:

- (a) **Description of Land**. To sell and convey to Purchaser land in the Township of Superior, County of Washtenaw, State of Michigan, more particularly described on <u>Exhibit A</u> attached hereto, (the "Property"), subject to the Permitted Exceptions (as defined below) free from all other encumbrances except those set forth in this Contract or those that accrue or attach after the date of this Contract through the acts or omissions of persons other than Seller, upon the terms and conditions set forth below.
- (b) **Terms of Payment.** That the purchase price for the sale of the Property to Purchaser is Two Million Four Hundred Thirteen Thousand Two Hundred Eighty and 00/100 Dollars (\$2,413,280.00), of which the sum of Two Hundred Fifty Thousand and 00/100 Dollars (\$250,000.00) has been paid to Seller prior to the delivery hereof, the receipt of which is hereby acknowledged, and the additional sum of Two Million One Hundred Sixty-Three Thousand Two Hundred Eighty and 00/100 Dollars (\$2,163,280.00) is to be paid to Seller, with interest on any part thereof at any time unpaid at the rate of five percent (5%) per annum while Purchaser is not in default, and at the rate of the lesser of eleven percent (11%) per annum or such maximum rate of interest allowed by law, computed upon the balance of the Purchase Price then unpaid, during the period of any default in payment. Commencing on the first (1st) day of the month following the date hereof and continuing on the first (1st) day of each month thereafter until the balance is paid in full, Purchaser shall make payments of Ten Thousand and 00/100 Dollars (\$10,000.00) per month. Purchaser may make prepayments of principal at its option and without any prepayment penalty or premium. Prepayments shall reduce amount of the final payment(s) but shall not reduce the amount of the monthly payments due as set forth above. All payments are to be applied first to interest and the balance to principal; provided, however, in the event Purchaser has defaulted hereunder, all payments of any kind received hereunder shall be applied first to amounts due and owing for attorney's fees and expenses incurred by Seller as a result of such default, then to amounts due for taxes and insurance premiums, if any, paid by Seller in accordance with Paragraph 3 below upon Purchaser's failure to pay same, then to unpaid late charges, if any, then to interest, then to principal. All of the purchase money and interest shall, however, be fully paid within eighteen (18) months from the date hereof (sometimes referred to herein as the anything herein to the contrary notwithstanding. "Maturity Date"), **PURCHASER** ACKNOWLEDGES THAT THE REQUIRED MONTHLY PAYMENTS WILL NOT BE SUFFICIENT TO AMORTIZE THE ENTIRE BALANCE OF THE PURCHASE PRICE WITHIN THE TERM OF THIS CONTRACT AND THAT THERE WILL BE A SUBSTANTIAL BALLOON PAYMENT DUE TO SELLER ON THE MATURITY DATE (IN THE AMOUNT OF IF THERE ARE NO DELINQUENCIES OR PREPAYMENTS UNDER THIS

CONTRACT). Payments shall be mailed to Seller at the address listed in the introductory paragraph of this Contract. Payment schedule is attached hereto as <u>Exhibit B</u>.

In the event any payment is not received by Seller within seven (7) calendar days after the due date, a late charge of \$100.00 will be added. The late charge is intended to compensate Seller for additional administrative fees and other costs that Seller may incur as a result of the late payment and does not constitute interest. Imposition of the late charge does not constitute an election of remedies, nor does it limit in any way Seller's remedies for Purchaser's late payment default.

2. Purchaser Agrees:

- (a) To purchase the Property and pay Seller the sum aforesaid, with interest thereon as above provided.
- (b) To use, maintain and occupy the Property in accordance with any and all building and use restrictions applicable thereto.
- (c) To keep the Property in accordance with all regulations imposed by any governmental authority, to not permit or take any action that would change the zoning, permitted use, taxable status or other status of the Property, to not permit or grant any liens, easements or encumbrances on the Property or Purchaser's interest therein, to not apply for any tax parcel splits or combinations, and to not enter any use agreements or development agreements or assign any of the development rights relating to the Property without Seller's written consent, which may be withheld in Seller's sole and absolute discretion.
- (d) To not construct any buildings or improvements on the Property or otherwise develop the Property, to keep and maintain the Property in as good condition as it is at the date hereof and not to commit waste or otherwise diminish the value of Seller's security. Purchaser shall grant Seller or Seller's representative(s) the right to enter upon and inspect the Property at such times as Seller or Seller's representative(s) request during normal business hours upon reasonable notice. Any breach of this subparagraph by Purchaser shall be a material breach of this Contract, entitling Seller to all of its contractual, legal and equitable remedies for a material breach.
- (e) To pay for any and all utilities serving the Property before the same becomes delinquent and to pay all taxes and special assessments hereafter levied on the Property before the same becomes delinquent.
- (f) To maintain and keep in full force effect, at its sole costs and expense, a policy of Commercial General Liability in the amount of at least One Million Dollars (\$1,000,000.00) per

occurrence, with a General Aggregate limit of at least Two Million Dollars (\$2,000,000.00), or such greater amounts as Seller may reasonably require, naming Seller and any other party designated by Seller as additional insureds. Each policy of insurance required to be maintained by Purchaser pursuant to this subsection be placed with insurance companies admitted to do business in the State of Michigan carrying a current rating of at least A-IX in "Best's Insurance Guide" and shall contain an endorsement requiring thirty (30) days' written notice from the insurance company to Seller prior to any cancellation in coverage of the policy. Upon the execution of this Contract, and, thereafter upon Seller's request and prior to the expiration of any policy required by this subsection, Purchaser shall deliver to Seller a copies of such policies and certificates of insurance in a form reasonably acceptable to Seller evidencing the policies of insurance required by this subsection, together with satisfactory evidence of proof of payment of premiums. Seller reserves the right to require Purchaser to maintain additional insurance coverage as deemed necessary by Seller in its reasonable discretion. Purchaser's insurance shall be primary and non-contributory with Seller's insurance. All policies of insurance shall be held by Seller as additional security hereunder and, in the event of sale of the Property on foreclosure, the ownership of all policies of insurance and the right to receive the proceeds of any insurance payable by reason of any loss occurring before or after foreclosure shall pass to the purchaser at the foreclosure sale, and Purchaser hereby appoints Seller its attorney-in-fact, in Purchaser's name, to assign and transfer all such policies and proceeds to such purchaser. Any breach of this subparagraph by Purchaser shall be a material breach of this Contract, entitling Seller to all of its contractual, legal and equitable remedies for a material breach.

- (g) That Purchaser has examined the Title Commitment (as defined in the Purchase Agreement) covering the Property and is satisfied with the marketability of title shown thereby.
- (h) That Purchaser hereby accepts the Property in its "as-is" "where-is" condition with no warranty or representation regarding the condition of the Property whatsoever, except as may be expressly set forth in the Purchase Agreement. The provisions of Section 11 of the Purchase Agreement are hereby expressly incorporated herein by reference.

3. Seller and Purchaser Mutually Agree:

Mortgage by Seller. That Seller may, at any time during the continuance of this Contract encumber the Property by mortgage or mortgages to secure not more than the unpaid balance of this Contract at the time such mortgage or mortgages are executed. Such mortgages shall provide for payment of principal and interest in monthly installments which do not exceed such installments provided for in this Contract; shall provide for a rate of interest on the unpaid balance of the mortgage debt which does not exceed the rate of interest provided in Paragraph 1(b); or on such other terms as may be agreed upon by Seller and Purchaser, and shall be a first lien upon the Property superior to the rights of Purchaser herein; provided notice of the execution of said mortgage or mortgages containing the name and address of the mortgagee or his agent, the amount of such mortgage or mortgages, the rate of interest and maturity of the principal and interest shall be sent to Purchaser by registered mail promptly after execution thereof. Purchaser will, on demand, execute any instruments demanded by Seller, necessary or requisite to subordinate the rights of Purchaser hereunder to the lien of any such mortgage or mortgages. In event Purchaser shall refuse to execute any instruments demanded by Seller and shall refuse to accept such registered mail hereinbefore provided, or said registered mail shall be returned unclaimed, then Seller may post such notice in two conspicuous places on the Property, and upon making affidavit duly sworn to of such posting, this proceeding shall operate

the same as if said Purchaser had consented to the execution of said mortgage or mortgages, and Purchaser's rights shall be subordinate to said mortgage or mortgages as hereinbefore provided. The consent obtained, or subordination as otherwise herein provided, under or by virtue of the foregoing power, shall extend to any and all renewals or extensions or amendments of said mortgage or mortgages.

- (b) **Encumbrances on Seller's Title**. That if Seller's interest now or hereafter be encumbered by mortgage, Seller shall meet the payments of principal and interest thereon as they mature and produce evidence thereof to Purchaser on demand, and in default of Seller said Purchaser may pay the same. Such payments by Purchaser shall be credited on the sums first maturing hereon.
- (c) **Non-Payment of Taxes and Insurance**. If default is made by Purchaser in the payment of taxes or insurance, Seller may, but shall not be obligated to, pay the charges therefor, and any amount so paid shall be a further lien on the Property payable by Purchaser to Seller forth with interest at the lesser of eleven percent (11%) per annum or the maximum rate allowed by law.
- (d) Assignment by Purchaser. That Purchaser shall not assign this land contract without the prior written consent of Seller, which consent may be withheld by Seller in Seller's sole and absolute discretion. Any such assignment by Purchaser without Seller's prior written consent shall be a default hereunder. That no assignment or conveyance by Purchaser shall create any liability whatsoever against Seller until a duplicate thereof duly witnessed and acknowledged, containing the address of the assignee, shall be delivered either personally or by certified mail to Seller and receipt therefor obtained. Purchaser's liability hereunder shall not be released or affected in any way by delivery of such assignment, or by Seller's endorsement of receipt or acceptance thereon. Notwithstanding any contrary provision in this Contract, Purchaser shall not sell, divide, transfer or encumber the Property until such time as payment and performance of this Contract has been completed, unless agreed to by Seller in writing.
- (e) **Possession**. That Purchaser shall have the right to possession of the Property from and after the date hereof, unless otherwise herein provided, and be entitled to retain possession thereof only so long as there is no default on its part in carrying out the terms and conditions hereof. If the land is vacant or unimproved, Purchaser shall be deemed to be in constructive possession only, which possessory right shall cease and terminate after service of a notice of forfeiture of this Contract. Erection of signs by Purchaser on vacant or unimproved property shall not constitute actual possession by it.
- (f) **Right to Forfeit**. That should Purchaser fail to perform this Contract or any part thereof, Seller immediately after such default shall have the right to declare this Contract forfeited and void, and retain whatever may have been paid hereon, and all improvements that may have been made upon the Property, together with additions and accretions thereto, and consider and treat Purchaser as its tenant holding over without permission and may take immediate possession of the Property, and Purchaser and each and every other occupant remove and put out. In all cases where a notice of forfeiture is relied upon by Seller to terminate rights hereunder, such notice shall specify all unpaid moneys and other breaches of this Contract and shall declare forfeiture of this Contract effective in fifteen (15) days after service unless such money is paid and any other breaches of this Contract are cured within that time, as provided by statute, prior to institution of any proceedings to recover possession of the Property.
- (g) **Acceleration Clause**. If default is made by Purchaser and such default continues for a period of forty-five (45) days or more, Seller, at Seller's election and with or without proceeding to

foreclose this Contract in equity, shall have the right to declare the entire unpaid balance hereunder to be due and payable forthwith, notwithstanding anything herein contained to the contrary. Upon such declaration, Seller may pursue an action on the debt or proceed with judicial foreclosure of this Contract and, in addition to recovering the unpaid balance and accrued interest thereon, Purchaser shall be responsible for all reasonable costs incurred by Seller, including reasonable attorney's fees.

- (h) **Time of Essence**. That time shall be deemed to be of the essence of every provision of this Contract.
- (i) **Notice to Purchaser**. That any declarations, notices or papers necessary or proper to terminate, accelerate or enforce this Contract shall be conclusively presumed to have been served upon Purchaser if such instrument was enclosed in an envelope with first-class postage fully prepaid, addressed to Purchaser at the address set forth in the heading of this Contract or at the latest other address which may have been specified by Purchaser and receipted for in writing by Seller, and such envelope was deposited in the United States government mail.
- (j) Interpretation of Contract. The pronouns and relative words used in this Contract are generally written in the masculine and singular. If, however, more than one person joins in the execution of this Contract as Seller or Purchaser, or either party be of the feminine gender or a corporation or other entity, such words, if not already so written, shall be read as if written in plural, feminine or neuter, respectively. The captions and section numbers appearing in this Contract are inserted only as a matter of convenience, and do not define, limit, or construe or describe the scope or intent of such sections of this Contract nor in any way affect this Contract.
- (k) Capacity of Parties. Any individual parties hereto represent themselves to be of full age. Any corporate parties hereto represent themselves to be existing corporations with their charters in full force and effect. Any partnership parties hereto represent themselves to be existing partnerships with their certificates in full force and effect. Any limited liability company parties hereto represent themselves to be existing limited liability companies with their articles in full force and effect. Any individuals signing this Contract on behalf of a corporation, limited liability company or partnership warrant and represent that they are duly authorized to sign this Contract and bind their respective entity to the terms and conditions contained in this Contract.
- (l) **Removal of Liens**. Purchaser shall keep the Property hereafter free and clear of all liens and encumbrances which arise due to Purchaser's acts or omissions. In the event that Purchaser, by his acts or omissions, causes or permits any such non-permitted lien or encumbrance to attach and fails to remove (which removal, in the case of a construction lien, may be accomplished by bonding off such lien in accordance with the construction lien act) any such lien or encumbrance within thirty (30) days after its attachment and written demand for removal, Seller shall have the right, but not the obligation, to remove such lien or encumbrance at its expense and Purchaser shall make prompt payment of such amount to Seller, plus all costs and professional fees incurred by Seller as a result of such lien, with interest at the default rate provided in paragraph 1(b) above. Any breach of this subparagraph by Purchaser shall be a material breach of this Contract, entitling Seller to all of its contractual, legal and equitable remedies for a material breach.
- (m) Waiver of Jury Trial. Seller and Purchaser hereby waive trial by jury in connection with any legal proceeding, including any counterclaim brought in any legal proceeding, arising out of

or in any way relating to this Contract or possession of the Property, excepting only actions by third parties for personal injury.

- (n) **Applicable Law; Successors**. This Contract shall be construed in accordance with and governed by the laws of the State of Michigan. This Contract shall be binding upon and inure to the benefit of Purchaser and Seller, their respective heirs, personal representatives, successors and permitted assigns. The parties hereto agree that this Contract cannot be modified, altered or otherwise amended without a writing being duly signed by both Seller and Purchaser.
- (o) **Notices**. Except as otherwise provided in this Contract, all notices required to be made hereunder shall be deemed completed and legally sufficient if mailed by certified mail, return receipt requested, or if delivered personally or by courier service, to the addresses first set forth above, or such other address as may be designated by either party in writing. Notwithstanding any provision of this Contract to the contrary, however, a copy of all notices from Purchaser to Seller under this Contract shall also be sent to Seller's attorney, Butzel Long, Attn: Geaneen M. Arends, 150 West Jefferson, Suite 100, Detroit, Michigan 48226 and all notices from Seller to Purchaser shall also be sent to Ronald Sollish, Esq., Maddin Hauser Roth & Heller PC, 28400 Northwestern Highway, Suite 200-Essex Centre, Southfield, MI 48034.
- (p) **Memorandum**. Purchaser shall be free to record, at its sole cost and expense, a memorandum of this Contract in a form reasonably satisfactory to Seller, and Seller agrees to execute the same at Purchaser's request. Neither Seller nor Purchaser shall record this Contract.
- (q) Assignment of Leases and Rentals; Security Agreement. As additional security for the payment and performance of its obligations under this Contract, Purchaser hereby assigns to Seller all of Purchaser's right, title and interest as landlord under any and all of the leases now or hereafter covering the Property or any portion of the Property, and all deposits, rents, issues and profits derived and to be derived from the Property, all pursuant to Act 210 of Public Acts, 1953, as amended, it being the intention of the parties that all rights granted to Seller pursuant to such assignment shall be exercised only after default by Purchaser in accordance with said statute as if this Contract were in fact a mortgage; provided, however, that if and to the extent that such statute may now or hereafter be held to be inapplicable to the validity or exercise of such assignment, the rights and duties of the parties shall nevertheless be valid, binding and enforceable as a matter of contract and as an agreement running with the Property to the fullest extent permitted by law. Upon demand, Purchaser shall execute a memorandum in recordable form evidencing the Assignment of Leases and Rentals contained in this subparagraph. Purchaser agrees to execute and deliver from time to time upon request of Seller such other instruments of assignment, conveyance and transfer and take such other action as Seller may reasonably request for the purpose of perfecting, continuing, amending, protecting or further evidencing the arrangements contemplated by this Contract or to enable Seller to exercise and enforce its rights and remedies under this Contract.
