## COMMITTEE TO PROMOTE SUPERIOR TOWNSHIP – "One Superior Place" Meeting January 18, 2023

**Remarks and Announcements –** Brenda Baker, Carla Bisaro, Nancy Caviston, Carole Hann, Margery Dosey, and Brenda McKinney attended; Kira Macyda, of Washtenaw County Parks & Recreation visited for part of the meeting. No regrets were received as of meeting time, but late regrets came from Ken Schmidt. Kira led off the agenda, telling us of progress at the Staebler Farm. Washtenaw County Parks has purchased the Folk School from Jason Gold; the multipurpose building nears completion, and rehabilitation of the Staebler Farmhouse is planned. Folk School classes should commence this fall. Kira also told us of a new preserve acquired by the County – the Lost Wagon Lake Preserve is on Gotfredson Road and should be available to the public in a couple of years.

**Library Display/Bookmarks/Superior Places Binders** – Carla and Carole told of their meeting with Mary Garboden of the Superior Township library. The options, a spot on the "slide show" video, or the hallway space for a poster bulletin board, did not find any favor. Other restrictions such as "competition" on Facebook listings, seemed uncooperative to the committee. Carole and Carla will pursue ideas for a more ideal Township presence at the library.

**Internet, Websites, Social Media –** Margery had sent a copy of her PowerPoint presentation to remind the committee of the Facebook content scheduling.
