A Board of Determination will meet to hear all interested persons, receive evidence, and determine whether the maintenance and improvement, as set forth in the petition dated March 6, 2024, is necessary and conducive to the public health, convenience, or welfare, according to Chapter 8 of Public Act 40 of 1956, as amended.

During the meeting:

- A brief history of the Drainage District will be presented.
- The roles, responsibilities, and decisions made by a Board of Determination will be explained.
- A presentation of the current condition of the drain will be given.

The Board of Determination members will then:

- Receive statements from the landowners and municipalities in the drainage district.
- Vote to determine if a project is necessary and conducive to public health, convenience, or welfare.

The decision made by the Board will determine if the Washtenaw County Water Resources Commissioner's Office may move forward with a project.

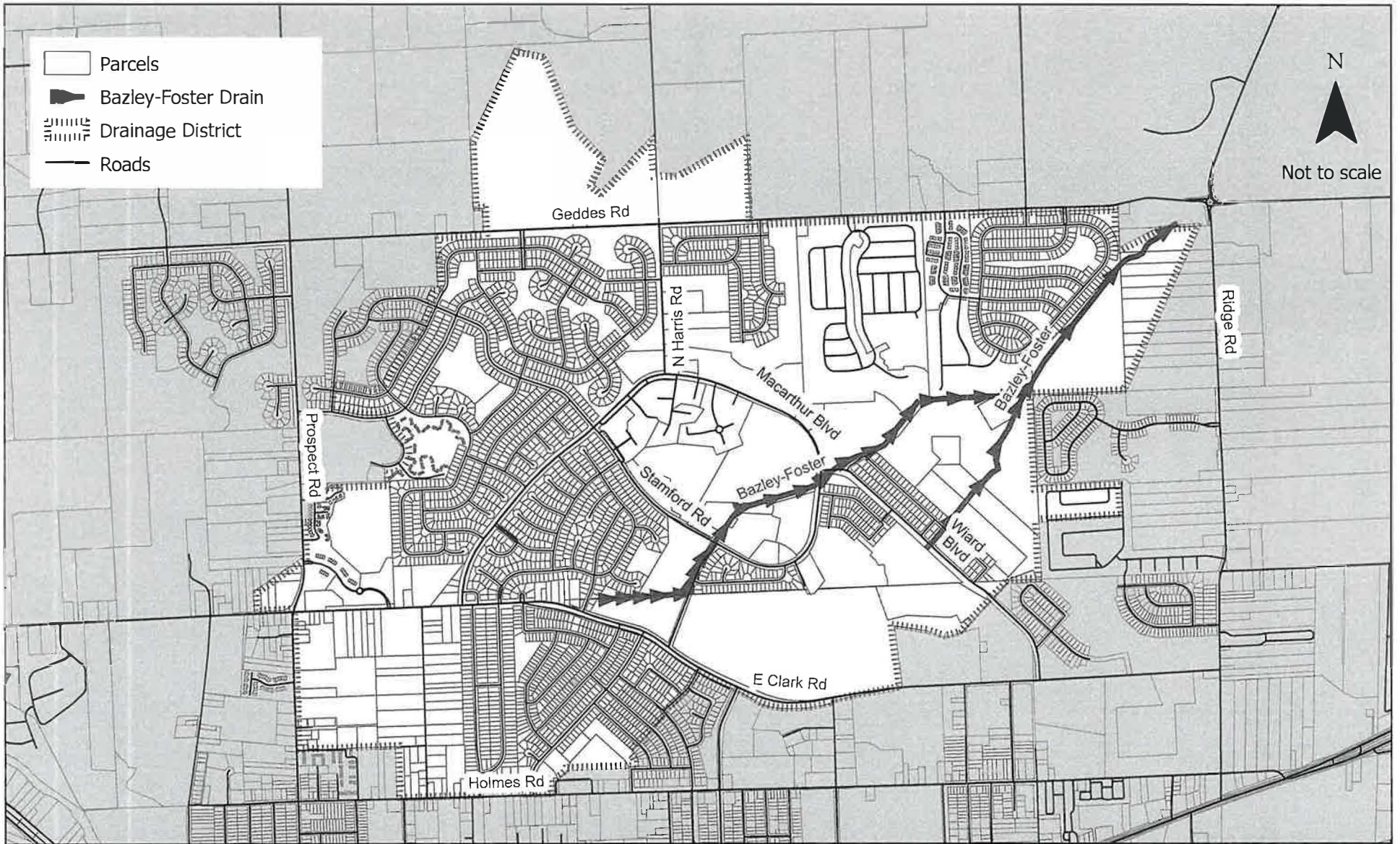

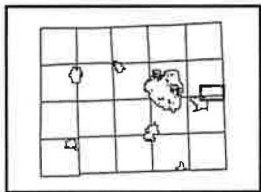
