Discussion included proposed updates to zoning districts, permitted uses, planned community standards, mixed-use and commercial zoning classifications, data center regulations, renewable energy provisions, and general modernization of the Township Zoning Ordinance. Board members asked questions and provided feedback regarding ordinance structure, land use compatibility, implementation concerns, and opportunities for additional public input and community engagement.

- **Jeff Yoder** expressed appreciation for the ongoing zoning ordinance review process and requested that updated draft versions of the ordinance be made available online for public review.
